4. Entries are encouraged either directly or from external contracted third parties acting for the putative nominee.
5. All Awards entrants agree to be bound by the decisions of the judges and accept no correspondence, telephone, email or communication of any kind will be entered into in relation to decisions reached.
6. All collaterals / material submitted in support of an entry (single or Multiple) are warranted by the entrant to be their property and is entered without any encumbrances by third parties.
7. The entrant indemnifies, and agrees to keep indemnified, the organizers of the Awards for any claims arising out of any material, statements or claims made as part of their entry for the said Awards.
